

	MUCCLECAD	added to the vehicle after market.
3	<i>MUSCLE CAR,</i> 1964-72	Examples - GTO, GSX, Charger, Chevelle, etc.
4	PONY CAR,	Examples - Mustang, Camaro, Barracuda, Challenger,
5	1964-70 SPORTS CAR	Firebird, etc.
6	DOMESTIC SPORTS CAR FOREIGN	
7	TRUCK	Any year, make, or model; stock, sport, or modified.
8	LOWRIDER	Ground clearance less than design specification.
