



# Simi Valley Corvettes

MINUTES OF MEETING TUESDAY, JULY 7, 2020

Because of COVID-19 Pandemic Stay-A-Home Orders, this meeting was held on Go-to-Meeting Virtual Meeting App.

Treasurer, **Patrick N** moderated the meeting.

Meeting start 7:32

No member count for this meeting.

**Cheryl S., President**, opened the meeting by hoping all had a great 4<sup>th</sup> of July holiday weekend.

**Celebrations:** **Bob S., VP**, asked if there were any guests present, which there were not. He then announced the birthday, wedding anniversaries & club anniversaries celebrations for the month of July. Notably, **48 years Wedding Anniversary for Bob & Cathy S.** and **50 years Wedding Anniversary for Steve & Joanna R.** Also discussed, there are a lot of special club anniversary members who have not been able to receive their pins. Cheryl suggested that we may consider mailing them, so that members will have them.

**Minutes Approval: Lois F., Secretary.** Lois asked for additions or corrections to the minutes from the last meeting, which there were none. Not having multiple screens to see all on her iPad, **Cheryl S.** made a motion to accept the minutes as written and 2<sup>nd</sup> from **Allen Z.** Minutes were accepted by members present with no exceptions.

**Treasurer's Report: Patrick N.** Patrick gave the financial report. A 6-month financial report with a 1 year comparison was sent to membership with the agenda for this meeting. He gave the balance in the club bank account with the amount for charities currently at \$795. If there were questions, members can contact him directly by phone or email.

## Club Business

**E-board** met prior to this meeting to discuss still having the annual club parties: Annual Picnic, Halloween Party & Holiday Party, because of current California State CDC guidelines due to the COVID-19 virus situation. The board agreed that the parties were not in compliance with these guidelines because of number of participants and the inability to appropriately social distance.

SVC Executive Board recommended cancellation of three events (Picnic, Halloween Party, Holiday Party). This action is taken due to the pandemic / CoVid-19. Patrick will organize a poll on Google forms and have Lois email to members to vote to discontinue to hold the events this year with a place to state comments.

(Later after the discussion about Angeles Crest) **Frank C.** asked if there is enough room at the Lemon Park to social distance and it was noted, yes. That participants would also bring their own chairs or be able to use reserved pavilions to enjoy their food, socially distanced.

The E-board is in possession of several items donated to the club. We would like to auction them off to members as contribution to our club charities. **Gregg B.** also would like to donate a C7 car cover, originally to have been as part of the White Elephant sale at the picnic. Board will decide on a way to have virtual auction for these items.

### **Rydell Chevrolet Sponsorship**

**Steve C.**, first noted that the **Corvette C8** won its first race at Daytona the weekend before.

Regarding Rydell Sponsorship, Steve suggested we forgo asking the dealership for the 2<sup>nd</sup> sponsorship payment for this year, as there has been no club expenditures for rent. Cheryl S. will contact Rydell to discuss.

### **Upcoming Runs & Events**

**Patrick N.** has organized a 160-mile round-trip, in-car run through Angeles Crest Highway to Wrightwood then back through Littlerock with stops at Whalley's Orchards for peaches and Charlie Browns Farms for lunch & shopping. It would be a 7-hour day, starting in Granada Hills at 7:00 AM.

Some members proposed that the group leave between 7:30-8:00 AM instead. Also, **Randy R.** suggested that the run head through Hwy 14 through Palmdale first because there would be less heat at that time, then after lunch at the Charlie Brown Farms or McDonalds, head home through Angeles Crest to Granada Hills.

Patrick said he would revise the route and timeline and create an online sign-up registration using Google Forms. A release will also be attached to have members agree to respect CDC guidelines for social distancing & masks. There will not be any "COVID Police" and he asked that all be respectful and safe.

**Judy S.** suggested that those who wish to purchase or pick peaches at Whalley's bring a cooler to keep the fruit in.
